Certified training, 4 February 2026 – 15 April 2026

Overview

This certified training offers a journey through the entire project life cycle with simplified cost options (SCOs). The training requires a bit of study and preparation at home, participation in interactive online meetings and finally the attendance to a two days in person event.

Who is it for?

The training is designed for staff of different programme bodies (e.g., managing authorities, joint secretariats, controllers, audit authorities), who would like to expend their practical knowledge about SCOs.

What will I learn?

By the end of the training, you will gain practical experience how to choose and justify different SCOs tailored to programme needs and capabilities. You will expend your knowledge on different SCOs combinations and experiences of SCOs application. Your skills will be expanded on how to work with SCOs at all stages of the project life cycle (communication to applicants, assessing project proposals with SCOs, implementing SCOs, verifying and auditing SCOs).

How long does the training take?

The certified training will be delivered over the course of 3 months. It will take between 20-25 hours to complete all the components of the SCOs for practitioners certified training.

How do I get my certificate?

We issue your certificate when you have completed all the mandatory components of the training. Please note that this training involves **an in-person event on 14-15 April 2026 in Zagreb (Croatia), which you must attend.**
